Treasurers Report Botts/Grondal

Finances are doing pretty good. We haven't got the most recent attorney bills as yet – they will be heavy. Cash flow is good. \$110,305 in cash assets this year compared to last year \$66,399. We are still running a tight ship for Operations.

Legal Status Smith

We have started depositions of BIA employees plus 6 or 7 others in Moses Lake, Manson/Chelan and Wenatchee – going to be pricey – this would be the final push for the January court motions date. The BIA had asked for summary judgment to vacate the land, but was denied. The next one or two months along with briefings are going to be the most costly. Our attorneys have been preparing for these depositions for the last couple of months. Once the papers are filed with the court in January, we could get action and/or decision from Judge Quackenbush within 30 to 90 days. The 1924 Act that defines how MA8 might be Restricted Lands is still an issue as well. Realistically, we should know more about the outcome by Spring of 2013.
